ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

OFFER PRICE

- The final Offer Price has been agreed to be determined at HK\$0.3 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

NET PROCEEDS FROM THE SHARE OFFER

- Based on the Offer Price of HK\$0.3 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting fees and commissions and other estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$21.0 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Net proceeds from the Share Offer” in this announcement and the section headed “Future Plans and Use of Proceeds” in the Prospectus.

APPLICATIONS UNDER THE PUBLIC OFFER

- The final number of the Public Offer Shares under the Public Offer is 60,000,000 Offer Shares, representing 30% of the total number of Offer Shares initially available under the Share Offer.
- The Public Offer Shares initially offered under the Public Offer have been moderately over-subscribed. A total of 7,205 valid applications pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service were received for a total of 581,730,000 Public Offer Shares, equivalent to approximately 29.09 times of the total number of 20,000,000 Public Offer Shares initially available under the Public Offer.

Due to the over-subscription in the Public Offer, the reallocation procedure as described in the section headed “Structure and Conditions of the Share Offer — The Public Offer — Reallocation” in the Prospectus has been applied. The final number of the Placing Shares allocated to a total of 132 placees under the Placing comprises 140,000,000 Placing Shares, representing 70% of the total number of Offer Shares initially available under the Share Offer.

A total of 71 placees have been allotted five board lots or less of the Placing Shares, representing approximately 53.8% of a total of 132 placees under the Placing. These placees have been allotted approximately 0.57% of the total Placing Shares after reallocation.
